

Meeting of New Committee_on Sunday, 3th June 2018 Sydney University Sport & Aquatic Centre, Darlington Road, DARLINGTON, NSW 2008

Meeting commenced at: 1205

Present:

Quorum: Quorum being met for a Committee meeting, the meeting was declared open.

The following decisions were made:

1. <u>Next AGM</u>: It was decided that the next AGM will be on the next day after the next Competition.

2. <u>Competition Committee</u>: This TCAA Committee authorises the Competition Committee, which will comprise of the following members:

Ken Goh (Convener) with members: Lina He; Gai Wanless; James Gao (Push Hands); Steven Heard; Eddie Nugent. The Competition Committee is authorised to add assisting members. Damon Bramich was coopted into the Competition Committee. Damon is considering ways to promote Push Hands further, possibly by offering more attractive awards personally.

3. Next Competition Venue & Date:

a. Venue.

It was decided that the Hall at the Sydney University Sport and Aquatic Centre (SUSAC) be again hired for the Competition.

b. <u>Date</u>.

It was noted that this year, the KW Victoria Championship and the KWA National Championship were both scheduled on 3rd June 2018. KWVic Championship was subsequently deferred to July. It was discussed whether it we should attempt to coordinate TCAA's event with KW competition organisers.

Ken informed that TCAA's date has been deliberately set for many years to be in June to avoid clashing with KWA National and State Championship then dates. Clashes have been avoided until this year when KW's events were delayed. To change now on a temporary change on KW's part may result in clashes at other times. Furthermore, TCAA has had to take the step of booking the venue a year ahead to be assured of getting the venue and will have to do the same for 2019.

<u>Decision</u>: Ken will balance the need for TCAA to assure itself a venue against the probability of achieving a permanent clash-free arrangement with KW dates. However the window preferred for TCAA event should remain between the first Saturday of June 2019 and first Saturday of May.

3. <u>Banners</u>: The new feather banners have been observed to be effective. They are recommended for other state reps to obtain from their own local sources.

4. <u>State Activity Funding</u>. It was reiterated that \$400 was available to each state rep to purchase useful items as well as "seed money" to organize state workshops to promote Tai Chi as well as TCAA membership.

The idea of promoting the TCAA with a TCAA T-shirt/Polo was raised by Damon. Ken noted that the idea had been raised before with designs, but did not come to fruition due to the logistical problems of sustaining the cost effective production, stocking, sale and distribution.

Decision. It was decided to evaluate the feasibility of a TCAA T-shirt/Polo shirt considering new printing technology now available may alleviate the logistical effort. It was agreed that "seed money" will be approved if a sustainable feasibility was assessed.
